Dear Mr. Langer:

On behalf of the Respondent-Relator, Harry Barko, we hereby submit this letter pursuant to Fed. R. App. P. 28(j) to notify the panel of a factual error made during Petitioner's reply argument.

In response to a question by the panel Petitioner's counsel stated that the attorney-client privilege legend appeared on the interview statements at the time of the employee interviews. There is nothing in the record to support this assertion. The declaration of Harry Barko states that during the interview there was "no indication that the purpose of their investigation was to obtain legal advice." Respondent's Addendum, A-70-71, Declaration of Harry Barko, ¶¶ 6-8.

Also contrary to Petitioner's assertion, the "Confidentiality Statement" in the record does not contain any privileged or attorney-client privilege legend. Respondent's Addendum, A. 28. The record does not establish that written interview statements were prepared or signed during the COBC interviews.
