Chikwata cheNWC's Global Wildlife Whistleblower Program chinoshandisa rubatsiro rwama whistleblower mumitemo yakafanana neLacey Act, huori hwevamiririri vedzimwe nyika pasi rose (Foreign Corrupt Practices Act), uye neweku kunyepera kuziva zviitiko (False Claims Act) izvi zvichiitirwa kubatsiridza nhengo dzemukati medzinyika kutaura dzimhosva dze kupambwa kwemhuka nedzimwewo mhosva dzemuka nemasango.

Mibhadharo nekuchengetedzwa kwema Whistleblowers

Kune mitemo yeU.S. yakasimba ino shandiswa pasirose, yakagadzirirwa kurwisana nemhosva dzeku pambwa kwemhuka dzemusango iyi inowanikwa ichipa ma whistlesblower mibhadharo mikuru. Mitemo iyi ino tsinhira kushanda kwama whistlesblower pasi rose, avo vanenge vakwanisa kuburitsa nekutaura kupesaniswa nekutyorwa kwemitemo yakakosha yekuchengetedzwa kwemhuka dzesango iyi inowanikwa ichizochengetedza mhuka, hove, zvirimwa, masango nedzimwe mhuka dzinowanikwa dziri pakushungurudzwa, kutorwa, kutumirwa kune dzimwe nzvimbo nevapambi vasina kodzero vanokwanisa kunga vari vagari vemu U.S. kunyangwe ne vasiri vagari vemo kana kuti makambani emunyika ye U.S.

Bato reNWC's Global Wildlife Whistleblower rinopa nzvimbo dzakachengetedza dzaunowana pamhepo (internet), idzi dzinoitirwa kupa vanhu vepasi rose mukana wekusvitsa nyeyuro yedzimhosva dzeku pambwa kwemhuka nama sango uye dzichi sanganisa mawhistleblower nemagweta ebumbiro remitemo avo vanovabatsira kusvitsa mhosva dzavanenge vataura kubumbiro remitemo yeU.S. pamwe nekuva kumbirira mubhadharo unoenderana nekutyorwa kwemutemo kwavanenge vasvitsa kwavari.
