# **About Us:**

National Whistleblower Center ("NWC") is the world's leading whistleblower organization. NWC has impacted whistleblower polices and protections since 1988. Our Board of Directors is composed of long-term whistleblower advocates, whistleblowers, and non-profit experts committed to justice.

### 2023 Key Accomplishments

#### Celebrating 10 years of National Whistleblower Day

NWC celebrated National Whistleblower Day this year on Capitol Hill and with an after-party at our Georgetown Offices. Over 300 people celebrated the day at the events. Mayor Bowser recognized National Whistleblower Day for the first time.

#### Legislative Wins

NWC celebrated major wins in AML legislation with the passage of the AML Whistleblower Improvement Act at the close of 2022. Its passage prompted the drafting of SEC, IRS, CFPB and DOT Whistleblower legislation throughout 2023. NWC's presence in international rulemaking and legislation reached new countries.

#### **Increased Judicial Action**

NWC's own Executive Director, Siri Nelson, was sworn in to the Supreme Court in November, doubling the Center's access to the court. NWC submitted *Amicus Curiae* Briefs in key cases such as for the reinstatement of Exxon Mobile Whistleblowers and for SOX Whistleblowers. One of which has already seen a victory ruling!

## **From our Executive Director**

In 2023 we celebrated 10 years of National Whistleblower Day (NWD) resolutions by the United States Senate, and this gave us an opportunity to reflect on the incredible work that NWC has achieved to change the culture around whistleblowing. Over a decade NWD has expanded to have a global reach and a historic number of federal agencies have accepted whistleblowing as a core component of anti-corruption efforts.

I was sworn in as a member of the Supreme Court Bar, joining Board Member Stephen Kohn and Board President Michael Kohn. In 2023, NWC filed two *amicus curiae* briefs at the Supreme Court preventing the watering down of the Sarbanes-Oxley Act and the False Claims Act (FCA). We also filed an *amicus* in a Third Circuit case concerning Exxon Mobil whistleblowers.

This year, one of our highlights was the opportunity to participate in important advocacy at the United Nations Conference of States Parties for the Convention Against Corruption. At this convening NWC was recognized for our work in fighting Environmental Corruption, and engaged in outstanding efforts to highlight the incredible success of rewards programs, and the necessity for including whistleblower reward regimes in all anticorruption efforts.

## Celebrating 10 Years of National Whistleblower Appreciation Day

Since its founding, National Whistleblower Center has advocated for whistleblower recognition and litigated individual cases. Twenty-five years of sustained practice culminated in the very first Senate resolution to recognize July 30th as National Whistleblower Day in 2013. Ever since, NWC has continued to work closely with Senator Grassley, who heads the Senate Whistleblower

Protection Caucus, and has been instrumental to NWD celebrations over the next ten years, to celebrate whistleblowers and ensure robust implementation and policy evolution.

National Whistleblower Day brings together various stakeholders involved in the field of whistleblowing. Over the past decade, this day has evolved into hybrid models, increased reach through CSPAN and other media and diversified to include global participants. Every year, NWD is increasingly recognized by federal agencies like HHS, EPA, and others.

- Support the enactment of Executive Order mandating that all federal agencies recognize July 30th as National Whistleblower Day.
- Assist federal agencies to incorporate whistleblowing as a core anticorruption strategy and educate federal employees about National Whistleblower Day.
- Work with global anti-corruption initiatives to incorporate whistleblower recognition.



# **Policy Progress**

In 2023, NWC wrote over 100 letters to legislators and federal agencies to monitor policies, acknowledge their success, and to provide support and accountability.




### **Policy Spotlight:**

In December, NWC traveled to Atlanta, Georgia to participate in the UN's CoSPIO. In anticipation of the major, international, anti-corruption conference, NWC joined 301 other civil society organizations and experts in signing an open letter addressed to the UN Convention against Corruption (UNCAC). The letter called for a strong resolution to be adopted at CoSPIO to prevent and combat environmental crime and corruption. NWC's own Scott Hajost helped to write the letter, a major win for NWC's Climate Corruption Campaign which was launched in 2020. At the conference, our three person delegation worked tirelessly to advocate for whistleblower protections and rewards. Siri Nelson addressed the general body on four occasions, championing NWC's best practice principles. NWC was proud to champion whistleblowers to the global community and ensure their needs were front at center at the conference.



## **Global Growth**



The International Visitor Leadership Program (IVLP) is the U.S. Department of State's premier professional exchange program. NWC has partnered with the State Department on this program since 2008, giving presentations to visiting foreign leaders. In the past 15 years, we have given talks to over 80 countries.

In **2023**, NWC participated in IVLP seminars for 30 countries. In addition, Siri Nelson joined eight international representatives to discuss whistleblowing in Washington D.C. as part of IVLP.

The **Americas Project** is a multi-year effort to increase awareness and support the adoption of effective whistleblower protection laws and transnational cooperation throughout the Americas.

In **2023**, Stephen Kohn delivered keynote speeches at a series of events in Mexico City and Monterrey, focused on ways whistleblowers in Mexico can use U.S. laws to fight corruption in the country "I have been able to learn about Whistleblowers cases from the experience of their defense attorneys. # Legislative Progress

#### Legislative Spotlight:

Since the passage of the AML Whistleblower Reform Act in late December of 2022, a new series of whistleblower bills have been introduced throughout 2023, offering a promising future for whistleblower legislation thanks to the new steam generated from the passage of the omnibus spending package



## 2023 Amicus Round-Up



In 2023, NWC filed three amicus curiae briefs. Two of the cases, Murray v. UBS Securities and Lindsey Gulden and Damian Burch v. Exxon Mobil Corporation, focused on the Sarbanes-Oxley Act and addressed issues surrounding reinstatement and retaliation. If not overturned, these cases could water down the protective impact of the SOX Act, putting thousands of whistleblowers at risk and reversing 20 years of precedent. In 2024, Murray v. UBS had a victory in the Supreme Court!

In a third case, NWC filed an *amicus curiae* brief in the Supreme Court's *United States ex rel. Schutte v. Supervalu*, a case that centers around the False Claims Act (FCA). This case successfully resolved in favor of strengthening the Act. 2023 was a successful year for NWC's action in the U.S. Supreme Court. In November, Executive Director Siri Nelson was sworn into the Supreme Court Bar, joining Chairman Stephen Kohn. Nelson's swearing in amplifies NWC's access to the Court, aiding our ability to submit *amicus curiae* briefs and to present arguments to the court.

### Mentoring the Next Generation of Whistleblower Advocates

NWC launched a Law Clerk Exchange Program in the summer of 2023. Program clerks work at NWC for the summer and spend part of their time at a local law firm. The first clerk, Titi Unegbu, was hosted at Zerbe, Miller, Fingeret, and Jadav.

NWC also hosted a highly successful internship program with 6 students, many from The University of California UCDC Program, which sends interested students to Washington, D.C. for a quarter to intern at their chosen site.
